# Contract for Participation in the THE ROCK. SHOW™ the April 2021 Virtual Tucson Experience

**1. Title:** TheRock.show

**2. Organizer:** JTIInc. 1735 N. Oracle Road, Tucson, AZ 85705

**3. Location, Dates, Hours:** TheRock.show, a virtual online platform: VIP Day April 9, 2021; general public April 10 (Saturday) through April 18, 2021 (Sunday); Open 24/7.

**4. Application for Participation:** Application is made by completing this contract and submitting it to registration@therock.show or by mail to JTIInc., 1735 N. Oracle Road, Tucson, AZ 85705. The Vendor herewith agrees to accept all rules, regulations, terms and conditions of the Show as being valid for himself/herself and employees. The Vendor accepts full responsibility, and is liable for any and all actions of any employees, or any persons sharing or subletting Vendor's assigned selling space.

**5. Conditions of Application:** The hire of exhibition space is for the entire duration of the Show. Upon application acceptance, the Organizer herein grants revocable license to use the exhibition booth assigned, subject to these terms and conditions. The Organizer makes no representations or warranties except as expressly set forth herein. The license granted is revocable by Organizer in the event Vendor shall violate this agreement.

**6. Booth Assignment:** Where feasible, the Organizer will assign the location requested by the Vendor. However, the Organizer reserves the right to change original space assignments if deemed to be in the best interest of the Show or for circumstances beyond the control of the Organizer.

**7. Admission requirements:** The Organizer reserves the right to determine Vendor eligibility for inclusion in the Show as well as accept listings of the Vendor's items for sale. The payment submitted with application will be refunded if application is declined. Applicants cannot legally claim the right to participate in the Show and applications may be turned down by the Organizer without providing a reason. Admission granted can be withdrawn by Organizer if the required prerequisites can no longer be fulfilled and all payments returned.

**8. Contract of Hire:** The contract of hire between the contractual partners (the Vendor and Organizer) becomes valid when the application is accepted. Organizer shall have full power to interpret the rules, terms and conditions of this contract to make such ruling as may be deemed by the Organizer to be in the best interest of the Show. Any written amendments of the foregoing rules, terms and conditions shall bind the Vendor. During the Show, due to its temporary nature, various unknown and anticipated contingencies may arise, and the Organizer reserves the right to interpret the relative rights of the parties in the light of such unanticipated circumstances and/or contingencies.

**9. Conditions of Payment:** A full payment is required, unless otherwise agreed upon in writing with the Organizer. Returned checks are subject to a \$35 service charge. Contact us at

registration@TheRock.show to obtain information about other methods of payment (e.g. PayPal, Credit Card, International Wire Transfers, Western Union).

**10. Vendor Cancellation:** Unforeseen circumstances can arise that will prevent a Vendor from participating in the show as planned. Therefore, release from contract is possible by written request, and refunds subject to the following schedule are available only to Vendors who have submitted the full payment: before 3/22/21: 80 % of the amount paid

3/22 to 4/4/21: 50 % refund

after 4/4/21: no refund

**11. Listing Requirements:** All items listed for sale must include a unique inventory code. This is mandatory.

**12. Booth Management:** It is the Vendor's responsibility to keep their listings up-to-date, during the Show.

**13. Set-up** is from March 22 to April 8. Set-up requirements include completing the vendor record, adding the vendor logo/icon, and uploading some product listings. If the allocated booth has not been set-up one day before show opening, then the space will be considered forfeit and the Organizer will be entitled to use or assign space otherwise. No refund will be made.

**14. Vendor can continually add, change, and update their listings** throughout set-up, and during the show itself, and are encouraged to do so. All sales listings will be removed from public view on April 19, 2021. Vendor contact information will remain up, to be retained as an online directory.

**15. Sales Transactions:** Vendors are solely responsible for all aspects of their sales transactions. TheRock.show is not responsible in any way for any of the commercial transactions between Vendors and Buyers. Vendors are responsible for any applicable sales tax on retail sales. Vendor agrees to cooperate fully with their local revenue and taxation authorities on all matters of Internet sales.

**16. Cancellation / Postponement of the Show:** If, due to circumstances beyond the Organizer's direct control and it becomes necessary to close down or postpone the date of the Show; this will not entitle Vendors to a release from contract or to a reduction in hiring fees. Vendor shall hold Organizer harmless against all other claims and liabilities to Vendor whether arising from expenses incurred, to be incurred, loss of anticipated profit or otherwise.

**17. Liability:** I agree to indemnify and save harmless JTIInc. and its agents, representatives, and employees from any and all charges, resulting from or in any way, directly or indirectly, connected with the performance or nonperformance of this agreement.

**18. This event takes place online.** Nonetheless, problems can develop from an individual's Internet connections. The Vendor agrees that the Organizer is not responsible for any transactional problems due to connectivity issues.
